2. Board of Director Reports

## President's Report – Dean Boles

• CSCTA has continued to improve and strengthen their role in the decision-making framework at the local, domestic and international levels. There is a common voice and solidarity of all coaches. They continue to establish sustainable working partnerships.

- They are working to further develop trust in the coaching fraternity and Swimming Community.
- The CSCTA is working through their committees to interact with Swimming Canada regarding important decisions that impact Coaches.
- CSCTA still has a seat on the WSCA Board of Directors.
- Staff Update:
  - Lauren Lavingna has been hired as the Administrative Assistant;
  - Chris Hindmarch-Watson, Executive Director: employment agreement is through August 31, 2017.
- Coach Education:
  - CSCTA continues to be one of Swimming Canada's largest funding partners for the NCCP and Coaching Development.
  - \$50,000 contribution for the 2011-12, 2012-13 and 2013-14 season
  - Reduced the contribution of \$25,000 for the 2014-15 season.
  - CSCTA continues to strengthen partnerships with their partners.
- Board Meetings take place regularly via conference call; The Board held a face-to-face meeting in Vancouver in May 2014. Another face-to-face meeting will take place in May or June 2015.
- Four Pillars were outlined at the meetings in June:
  - 1. Ethics and Professional Practice
    - Policies, Screening of Members, Code of Conduct
  - 2. Education & Professional Development
    - NCCP, Regional Conferences, National Conference, Personal Coach Program, Coach Grant program, Professional Development
  - 3. Awards/Recognition
    - Domestic Excellence Awards, Provincial Coach of the Year Awards, Olympic/Paralympic Medal Incentive Funding
  - 4. Operations
    - Registration, Webpage, Finance, Human Resources, Day to day

#### Policy, Governance & Professional Practice - David Fry

- Templates for dealing with positive responses to screening questions continue to be evaluated and reviewed
- Continue to work closely with the Provincial Sections and National partners to develop a framework for jurisdiction for complaints
- All policies and the Code of Conduct were reviewed extensively last Spring with changes implemented in August 2014.
- Continued to screen all applications for membership and process any positive responses to the Screening questions.
- Review and process any and all of the complaints that are received against the CSCTA.
- David extended thanks to Dr. Peter Vizsolyi for his ongoing assistance in each of these areas and the expertise of Chris Hindmarch-Watson in expediting each stage of the process.
- Chris Hindmarch-Watson attended the Safe Sport Conference in February 2015 with Ken Radford (SNC) in Colorado Springs. Look for a joint venture around this as they move forward.

#### Operations – Tom Johnson

#### Registration

- No major changes to the registration process
- Registration numbers are healthy and just over 2,200 Coaches
- Relationship with I Can Swim and Teacher memberships are still under review and discussion.
- Over 360 Coaches who have been paid for by their clubs but have not yet completed screening/registration. Coaches are reminded that they are not members until they complete the screening portion of registration. It is important that Head Coaches ensure their Assistant Coaches are fully registered. The Club Register through the Swimming Canada Registration site can verify the status.

#### **Funding Programs**

- Personal Coach Programs

#### **NCCP**

- Working with Swimming Canada to ensure the program is accessible
- Investment level was reviewed and reduced to \$25,000 for the current 2014-15 year.
- National Conference in Calgary in September was very successful with a representative turnout. As an organization this is a great opportunity for Coaches to work together and build the association with a great value add for the Coaches (professional development).

#### **Professional Development- Ryan Mallette**

**Regional Conferences:** 

- Increased support in 2014 from \$7500-\$10,000 across five separate conferences
- Support will continue for the 2015 Regional Conferences

#### National Conference:

- Held in conjunction with the SNC AGM, Officials Symposium and other meetings
- Very successful weekend in Calgary
- Focus on Canadian content
- Next National Conference will be September 2016, location TBC

#### Video Project:

- First video (activation video) released in conjunction with the National Conference and available to all Members.
- There are plans for a number of other videos utilizing the skill sets of IST professionals.
- Thanks to Eugene Liang, Dr Allan Wrigley and Graham Olson for their support on this project.
  - Personal Coach Program:
- CSCTA provided funding to non-selected personal coaches for the 2014 Pan Pacific Championships in Australia (\$10,000).
- CSCTA will provide funding for non-selected personal coaches to the FINA World Championships, Pan Ams, IPC World Champs and Para PanAm Games this summer (\$27,000 total).
  - Other programs under consideration:

- Several conference calls and memos have been sent to Swimming Canada focusing on:

Discussions with Swimming Canada on these issues are ongoing. Communications have been very positive, however it is still in its infancy. The role of the Committee is to build the bridges and ensure there is an improved understanding on decision-making.

- Committee held two conference calls and two sub committee conference calls so far this year focusing on a number of different items including:
  - Bonus swim structure at all national meets
  - Order of events
  - Rule and scoring changes at Easterns/Westerns
  - Selection process for Open Water swimmers
- Two memos sent to Swimming Canada related to:
  - Bonus swim structure at Olympic Trials
  - Order of events at the Canadian Swimming Championships

- Communication and discussion with Swimming Canada is continuing both subjects

- CSCTA is working on a communication strategy back to the members on the correspondence with Swimming Canada at their General Meetings. The CSCTA Board of Directors evaluates the work of all committees and will communicate as required to the members.
